WHAT DOES IT MEAN TO BE A CITIZEN?

- Automatic at Birth (in/out of the U.S.)
 - Just lucky I guess
- Automatic acquisition of citizenship after birth
 - Just lucky I guess
- Naturalization
 - Choice, must "earn" it

NATURALIZATION

Pathway to U.S. Citizenship

For an adult immigrant to become a U.S. citizen, he or she must go through the process of naturalization. GENERAL requirements for naturalization call for the immigrant to:

STATUTORY REQUIREMENTS

INA 316:

- **Residence**: 5 years as a permanent resident, during which time the applicant has spent more time in the U.S. than out & has lived within the USCIS filing district for at least 3 month prior to filing.
- Absences: Any absence from the United States of 6 months or longer during the 5 year period breaks the residence requirement and could be considered abandonment of status.
- Good Moral Character INA 101 GMC & 8 CFR 316.10
 - What on earth does it mean to have good moral character? Judge not lest ye be judged yourselves.
 - A case-by-case analysis taking into account the statutory requirements of GMC and the standards of the average citizen in the community of residence.

GOOD MORAL CHARACTER CONTINUED....

- a. For the purposes of this chapter- No person shall be regarded as, or found to be, a person of good moral character who, during the period for which good moral character is required to be established is, or was-
- b. (1) a **habitual drunkard**;
- c. (2) Repealed.
- d. (3) a member of one or more of the classes of persons, whether inadmissible or not, **crimes involving moral turpitude, prostitution, drug offenses**
- e. (4) one whose income is derived principally from illegal gambling activities;
- f. (5) one who has been convicted of two or more gambling offenses committed during such period;
- g. (6) one who has given false testimony to U.S. government
- h. (7) Confinement in jail or prison of 180 days or more, as a result of a conviction.
- i. (8) one who at any time has been convicted of an aggravated felony (as defined in subsection (a)(43)); or
- j. (9) one who at any time has engaged in **Nazi persecution**, participation in genocide, or commission of acts of torture or extrajudicial killings) or 1182(a)(2)(G) of this title (relating to severe violations of religious freedom).

- a. Child Support
- b. Criminal History
- c. Traffic violations
- d. Deportable offenses
- e. False statement to USCIS officer

INA 337

"I hereby declare, on oath, that I absolutely and entirely renounce and abjure all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, of whom or which I have heretofore been a subject or citizen; that I will support and defend the Constitution and laws of the United States of America against all enemies, foreign and domestic; that I will bear true faith and allegiance to the same; that I will bear arms on behalf of the United States when required by the law; that I will perform noncombatant service in the Armed Forces of the United States when required by the law; that I will perform work of national importance under civilian direction when required by the law; and that I take this obligation freely, without any mental reservation or purpose of evasion; so help me God."



WHAT'S THE WORST THAT CAN HAPPEN?

- Examples....
 - Outdated forms
 - Filing Fee issues
 - Cannabis
 - Spouses and children
 - Being too honest
 - Referral to Immigration Judge for Deportation

MOST COMMON REASONS FOR DENIAL

- Lack of GMC
- Failure to respond to a request for more evidence
- Civics/English Requirements

N-400 FORM AND FILING

- Let's take a look at the form: N-400 https://www.uscis.gov/n-400
- What does it cost? \$640 (Add the \$85 biometric fee for a total of \$725). You may pay the fee with a money order, personal check, cashier's check. If you pay by check, you must make your check payable to the U.S. Department of Homeland Security.

Exceptions:

- Applicants 75 years of age or older do not need to pay a biometric fee. They only need to pay the \$640 filing fee.
- No fee is required for military applicants filing under section 328 or 329 of the INA.
 - How long does it take?/Steps after filing: Receipt Notice, Fingerprints, Interview, Decision
